Who are The Heralds Trust?

The Heralds Trust is a not-for-profit, non-denominational ministry in Scotland, established in 1970, and funded by supporters.

The Heralds' primary function is to equip and enable individuals and churches to carry out the proclamation of the Gospel message. This is done through evangelism seminars and programs for training, encouragement, and networking.

The goal of The Heralds is to provide key areas of ministry support for churches and individuals to enable them to grow in confidence in the Gospel message and to lead with purpose and vision. We seek to be 'Heralds' of the Gospel.

Why intern with us?

The Heralds Trust desires to see local churches involved in evangelism and discipleship. In the post-modern culture of Scotland, many churches and believers are not actively involved in sharing their faith. This may be due to lack of resources, support from the church, training on how to evangelize, or education as to why evangelism is central to the Gospel.

The Heralds Trust is unique in its ability to meet these needs. The Trust provides the curriculum and support for the local church to begin an evangelism and discipleship program. The internship is designed to be the link between the Trust and that church. The intern will work with the leadership of the church to develop and lead an evangelism and discipleship opportunities using the resources from The Heralds Trust.

The Heralds Trust is looking for men and women who have a desire to serve the Lord in local church ministry and who are prepared to lead in evangelism and discipleship. The Gospel Apprentice program is ideal for recent graduates who would like practical application of their chosen fields as well as opportunities to learn and refine skills in preparation for future ministry. The Heralds Trust's goal for interns is that each intern will grow and mature as believers and ministry leaders in preparation for what God has prepared for each one.

Cost: \$10,000 USD

Dates: August-June

Room & Board: Host family

Transportation: Via host family/church members, public transportation (cost covered), bicycle (possibility), walking.

Accountability: The intern will be evaluated and held accountable The Heralds Trust and the leadership of the local church. This will include weekly/biweekly meetings with mentor, monthly reports, and a final report to the Trust and the church of reflections and learning outcomes.

Responsibilities: Developing and leading an evangelism and discipleship program suited to the church.



Learn: Work with and learn from Ian Leitch and Robert Bell, both alumni of MBI, who have a combined 50+ years of ministry experience

Network: Prospects to network with numerous Christian organizations

Opportunities: The needs are great and allow for creativity in implementing programs per personal experiences and preferences

Ministry: Experience ministry in a post-modern culture

Language: English speaking country—no language studies or interpreters needed

Affordability: Support is split between the church and the intern; the intern is only required to raise \$10,000 USD for the entire year

Cultural experience: Live with a Scottish family and work with the Scottish church

History: Learn the role of Scotland in the Reformation, missions, theology, education, etc.

Nature: Explore some of Scotland's stunning natural beauty, including lochs, mountains and moors

Graduation Requirement: Complete internship requirement for graduation


Summary

The cost of the internship will be split evenly by the intern and the church. For a nine-month internship, the cost to the intern is approximately \$10,000 USD. This includes room & board, training & personal development, program expenses, flights, insurance, visa, and ministry support. The church will cover the remainder of the needed funds.

All support raised by the intern will be routed through The Heralds 5013(c) 'Friends of the Heralds NFP' for USA Interns. Financial receipting and accountability to donors from the United States will be worked through this office.

Gospel Apprentice Support

Support is divided into three parts, with a third of the total cost due every three months. The first portion is due by the beginning of the internship (August), the second three months in (November), and the remaining third due six months in (February). The intern is responsible for communicating with supporters, both for financial support and prayer coverage.
